

## CERTIFICATE OF INCORPORATION OF

Albany Andhra Association, Inc

Under Section 402 of the Not-for-Profit Corporation Law

**FIRST:** The name of the corporation is:

**SECOND:** The corporation is a corporation as defined in subparagraph (5) of paragraph (a) of Section 102 of the Not-for-Profit Corporation Law.

**THIRD:** *(Select one)*

The purpose for which the corporation is formed is any purpose for which corporations may be organized under the Not-for-Profit Corporation Law as a charitable corporation.

The purpose for which the corporation is formed is any purpose for which corporations may be organized under the Not-for-Profit Corporation Law as a non-charitable corporation.

The purpose or purposes for which the corporation is formed are as follows:

- (A) To serve backward regions of Andhra Pradesh through sustainable community based projects in public health, medical, education, sanitation and cultural propagation.

  - (C) To provide services for differently Enabled and Disadvantaged people of Andhra Pradesh.
  - (D) To conduct service based projects for Albany Andhra Youth to develop sense of service and leadership skills.
  - (E) To raise, solicit, and collect funds and donations either directly or in cooperation with other not-for-profit organizations to support the objectives of the Corporation.
  - (F) To provide a forum for exchange of information and mutual cooperation among other Non-Profit Organizations with similar goals across USA.
  - (G) The Corporation will not perform any activities mentioned in Section 404(a) through (w) of the Not-for-Profit Corporations law of the State of New York.
  - (H) The Corporation will not be a religious Corporation, nor it will perform religious services as defined under the relevant sections of Religious Corporations Law of the State of New York.

The following language relates to the corporation's tax exempt status and is not a statement of purposes and powers. Consequently, this language does not expand or alter the corporation's purposes or powers set forth in paragraph THIRD.

(A) Notwithstanding any other provision of these articles, the corporation is organized exclusively for religious, charitable, educational and literacy purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or corresponding section of any of future federal tax code and shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code , OR, a corporation, contributions to which are deductible under Section 170(c)(2) of Internal Revenue Code, or the corresponding section of any future federal tax code.

(B) The corporation shall have no capital stock and no shareholders, and no dividends or pecuniary profits shall be declared or paid. However, the corporation shall have members. The rights of membership in the corporation shall be governed by the bylaws of the corporation, as such as bylaws may be amended from time to time, and as are not inconsistent with any provision of this Certificate of the Incorporation. Member may be divided into one or more classes.

(C) No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, director, officers or other private persons, except that the corporation shall be authorized to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its purposes as set forth in this certificate of Incorporation.

(D) No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf of, or in opposition to any candidate for public office.

(E) In the event of dissolution, all of the remaining assets and property of the corporation shall after deducting all applicable expenses thereof be distributed to one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code, Or, to the federal government, Or, to the state or local government for a public purpose upon approval of Justice of the Supreme Court of the State of New York.
