# AAA Elections for the term starting January 2017

---

## Introduction

Albany Andhra Association (AAA) is incorporated in New York State as a non-profit organization. AAA's current officers will complete their term at the end of December 2016.

The AAA Election Committee is charged with the task of soliciting nominations & conducting elections for the AAA officers' term starting from January 2017.

The Appeals Committee nominated by the AAA officers will be in charge of resolving any disputes the candidates may have in these elections.

## Open Positions

Based on the AAA by-laws, the Election Committee is inviting the nominations from AAA Members for the following AAA Officers positions:

- The President - 1 post
- Board of Director - 8 posts
- Board of Governor - 3 posts

## Nomination

Any eligible life member can nominate himself/herself for any one AAA Officer's position by completing the Nomination Form. Only self-nominations are accepted. Nomination form must be signed and dated.

Completed Nomination Forms shall be sent electronically (scanned copy) to [aaa.electioncommittee@gmail.com](mailto:aaa.electioncommittee@gmail.com) or by postal mail to Lakshmi Narayana K, 49 Valleywood Dr, Glenville, NY 12302. Completed nomination forms should reach AAA-EC on or before **October 29, 2016 11:59 PM**.

Upon receiving the nomination, the election committee will confirm the receipt of the nomination by email. If you do not receive this confirmation, call one of the election committee members. Election committee will also publish the nominee names [here](#), within 24 hrs. from the time nomination received.

Upon verification of eligibility of the candidate, AAA-EC will confirm the nomination by e-mail on or before November 5, 2016 11:59 PM. The candidate will be added to the slate of candidates.

## Withdrawal

If a candidate wishes to withdraw his/her nomination, they can do so on or before **November 12, 2016** 11:59 PM. Withdrawal must be sent by the candidate himself/herself by email to the Election Committee at [aaa.electioncommittee@gmail.com](mailto:aaa.electioncommittee@gmail.com).

AAA-EC will publish nominees list to all AAA members by e-mail and will also be published on the website on or before November 15, 2016 11:59 PM. AAA-EC will also communicate the details electronic voting process at this time.

## Elections

Elections will be conducted if there is more than one nomination for the President position, or more than 4 nominations for the Board of Direction positions, or more than one nomination for Board of Governor positions. AAA Elections will be conducted electronically (online) for only the positions required. Online voting is scheduled on **December 03, 2016** from 00:01 AM to 11:59 PM.

## Declaration of successful candidates

In the event of no elections, successful candidate names and positions with term will be declared on November 13, 2016.

In the event of elections, successful candidate names and positions with term will be declared on December 04, 2016.

Successful candidate names will be declared to AAA Officers on the date mentioned above. All the AAA members are welcome to attend. The venue and time will be communicated to all members at a later date. Election results will also be communicated to all AAA members through email.

## Verify Membership

Per by-laws elections shall be conducted electronically. Each member intending to cast the vote in the election must have a valid email on file with the AAA membership committee. In case of family membership, a separate email is required for spouse.
